# Contract For Brides and Bridal Parties

For hair services to be rendered to the client on her wedding day and in consideration of the mutual covenants and promises contained in this Agreement, the parties agree to as follows:

(A)

Cost of Styles:

- Bride: \$180
- Bridal Trial: \$100
- Bridesmaids: \$140
- Half up: \$100
- Styled Down /Curls Only/Flat Ironed: \$75
- Blow Dry: \$60
- Junior Bride/Flower Girl: \$85

(C) Payment:

- To reserve your date, a non-refundable \$150 deposit is due the day of the trial which will be applied and credited toward the overall amount due for the stylist's services to be provided on the day of the wedding. Deposits can be made with cash or credit. Leftover balances will be accepted in CASH and or Venmo ONLY on the day of the wedding.  
\*\*Gratuities are NOT included in rates above.
- Trial of bridal wedding styles is required and should be scheduled at least (1) month prior to the wedding date to ensure the desired style is achieved.
- Client should bring a variety of pictures of desired style for the day of the trial. If the client should need their hair to be blow-dried BEFORE receiving the style, there is a \$35 up charge included. Clients should come with hair BLOWN DRY WITHOUT IRON USE on hair the day of the wedding.

(D) Travel Fees / Other Fees:

- Travel services within Connecticut vary by location. A charge of up to \$100 is required for traveling from 15 to 100 miles outside Shelton, CT.
- Out-Of-State Fees: \$125 +Up

- The calculation of miles shall be based upon the calculation of mileage as made by Google Maps.
- The client and/or any member of her bridal party shall be subject to an additional charge of \$20.00 to be added to the final invoice in any instance where any such person(s) fails to arrive at the time previously designated for services by the stylist.

## (E) Time Allotted:

- Stylist will decide how much time is required for all services contemplated by this Agreement to be completed. Client will provide the latest time by which all hairstyles must be completed on the wedding day, and the stylist will determine the start time for services. All persons receiving services must be on location at the start time as stated in the paragraph above.
- On the day of the event the client and all members of the wedding party **MUST WEAR** “zip up” or “button down” shirts and come makeup free.
- Stylist will not be liable for damaged hair or makeup due to constricting clothing. When artist must “re-do” a style, that member will incur an additional fee.
- Client and bridal party members **MUST** come with washed and blow-dried hair. If a blow dry is needed an \$35 fee will be added.

## (F) Termination of agreement/Cancellations:

- The client may terminate this Agreement at any time upon giving (2) two months prior notice to stylist via email to [shearvision37@gmail.com](mailto:shearvision37@gmail.com). In the event the client fails to give notice to the stylist in a timely manner, as specified herein, the client shall be responsible for the full payment to the stylist as set forth under the cost of styles. Payment will be due on or before the wedding day as indicated in this agreement.
- In the unlikely event of a stylist's illness or any other circumstances beyond the control of the stylist, the stylist shall put forth best efforts to procure a substitute stylist of equal skill and ability, to fulfill the obligations of the agreement. In the event the client rejects or declines the recommended substitute stylist, the client shall only be entitled to a full refund of all money paid by the client. The stylist failure to obtain or procure any such substitute stylist shall not constitute a material breach of this Agreement.
